

**NRA NATIONAL  
INDOOR CONVENTIONAL  
PISTOL POSTAL MATCH**

The purpose of this postal match is to offer all conventional pistol competitors, both new and experienced, an opportunity to participate in a nationwide pistol postal competition.

**MATCH CONDITIONS**

*This is an indoor postal match. You may choose to fire on an outdoor range if you need to. Competitor acknowledges they understand they may be at a disadvantage due to wind/light and other outside conditions.*

**ELIGIBILITY**

An individual may enter this match only once per calendar year. Membership with the NRA is not required **but is encouraged.**

**FIRING DATES**

Firing may be done any time BETWEEN January 1<sup>st</sup> and December 27<sup>th</sup>.

**ENTRY CLOSING DATE**

Entries may be made at any time provided scores are received by December 27th.

**RULES**

Current NRA Pistol Rules will govern. NRA Rule Books are now available on line in PDF format at: <http://competitions.nra.org/official-nra-rule-books.aspx>

**EQUIPMENT**

.22 caliber pistol or revolver may be used. See NRA Pistol Rule 3.4.

**DISTANCE** - 50 feet.

**TARGETS**

Targets will not be provided by the NRA. They may be acquired locally or NRA will provide a list of official target manufacturers on request. Competitors must identify their targets prior to firing by signing the back of each target. Targets are not required to be returned to NRA, but must be retained for 6 weeks AFTER scores are posted on-line.

Targets required are as follows:

**SCORING**

All targets will be scored by the competitors. All scores will be final. NRA no longer requires targets to be mailed in. Please send only the completed score sheets. You may email scores to [dbullock@nrahq.org](mailto:dbullock@nrahq.org) or fax to (703) 267-3941.

**COURSE OF FIRE** - 60 shots

**TIME LIMITS**

Slow fire - 2 strings of 10 shots, 10 minutes per string.

Timed fire - 4 strings of 5 shots, 20 seconds per string.

Rapid fire - 4 strings of 5 shots, 10 seconds per string.

**WITNESS**

All record firing must be witnessed by a current NRA member (Provide witness NRA membership number).

**ENTRY FEE**

\$10.00 per entry. All participants will receive a Postal Hat Pin.

**AGGREGATE AWARD WINNER**

The winner will receive a personalized plaque. **To qualify for this award you must also participate in the NRA National Center Fire Pistol Postal.** The combined scores from both postals will be computed and a single winner will be selected.

**POSTAL WINNER**

WINNER – Will receive a plaque with the winning score engraved.

**NEW SHOOTER** defined as one who has never held an NRA pistol classification AND has never shot in this match. To be considered for these awards the proper special category(s) must be indicated on the firing report sheet.

**CLASSIFICATION AWARDS**

To qualify for these awards you cannot have won the Conventional Championship or the Aggregate Championship and must specify your NRA classification along with your NRA Membership number on the Firing Report sheet. If you do not provide us with this information, you will be classified as a **MASTER** shooter. *All competitors without a current NRA classification will be placed in the Master class.* The classes are as follows:

**HIGH MASTER          MASTER          EXPERT          SHARPSHOOTER          MARKSMAN**

Minimum of ten shooters per class for first award. Additional awards will be based on one award for every fifteen (15) entries received in each class. **All classifications will be checked.**

If there are fewer than 10 competitors in a class, they will be combined with the next higher class. If there are still fewer than 10 competitors, the combined class will be combined with the next higher class until the minimum of 10 competitors is achieved. In no case will any competitors of lower classification be combined with the High Master Class.

**PLEASE NOTE:** It is the responsibility of the competitors to check their scores listed in the on line results and to notify the NRA of any errors or omissions prior to the expiration of the challenge period. The challenge period timeframe will be included in the results. At the conclusion of the challenge period all scores are final and no changes to the results are allowed. (See appropriate NRA Rule Book, Sections 16 and 18.)

## NRA NATIONAL CONVENTIONAL .22 PISTOL POSTAL MATCH INSTRUCTIONS

**Targets Required:** Quantity – Six total targets – (2) B-2 and (4) B-3. For a list of licensed NRA target manufacturers visit:

Before firing, please do the following:

1. Print your name and complete mailing address on this report where indicated. Sign the back of each target, prior to firing.

2. If you are eligible for the Special Award Categories be sure to check only one box. A few eligibility requirements are as follows see NRA Rule 2 for further explanation if needed.

- **NEW SHOOTER** - An individual may compete as a New Shooter if they have **never held** an NRA Pistol classification or have **never competed** in this postal. A new shooter may use their temporary classification, if they have one, based on the scores recorded in their temporary score record book. To determine a temporary classification see rule 19.14 in the NRA Pistol Rule Book. Rule Books may be obtained **on-line at <http://materials.nrahq.org/go>**.
- **SENIOR** – A person may compete as a senior beginning on January 1 of the calendar year in which his or her 60<sup>th</sup> birthday occurs. NRA Rule 2.2.1
- **JUNIOR** – A person may compete as a junior through December 31, of the calendar year in which the twentieth birthday occurs. NRA Rule 2.3

3. Print your name on each target.

4. On the 2 slow fire targets (B-2) - Mark one "Slow Fire - Stage 1" and the others "Slow Fire - Stage 2". .

On the 4 Timed and Rapid fire targets (B-3) - Mark one "Timed Fire - Stage 1" and one "Timed Fire - Stage 2", the same applies for the "Rapid Fire" stages. Mark one "Rapid Fire - Stage 1" and one "Rapid Fire - Stage 2".

Ten (10) shots per target are to be fired on the Timed and Rapid stages.

5. Target Seals are no longer required.

Competitors will score all targets. Return scores sheets to:
